The Carter government is in crisis. It is the struggle of the American and international working class which has forced this crisis. You don't believe it?

What better picture could there be than the head of the largest imperialist power in the world, standing with his ally, the Shah of Iran, on the White House lawn as clouds of tear gas came across from a massive demonstration against the Shah's visit just yards away?

Carter, with his silly grin, pretending nothing was happening as all those around him, including the Shah, started crying and wiping their eyes. And later, Carter trying to make a joke by "apologizing to the Shah for the air pollution in Washington today."

When someone makes jokes like that they are really shaking inside. This demonstration was the largest demonstration and most violent one in front of the White House since the Vietnam War. The fight of the Iranian students for their freedom has touched a responsive cherd in the

of the Iranian students for their freedom has touched a responsive chord in the American working class.

The American working class wants its freedom too and is ready to fight for it. Carter knows this. His "human rights" fraud is a desperate attempt by a terrified bourgeoisie to convince the American working class that Carter and the Democratic Party stand for freedom too.

Carter and the Democratic Party stand for "freedom" all right. Freedom to exploit and smash the working class and its youth. But Carter's government is in crisis today because the Democratic Party has been unable to convince the American

has been unable to convince the American working class that this is the kind of

working class that this is the kind of "freedom" they want.

Striking iron one workers in northern Michigan and Minnesota carried signs in a recent demonstration saying "We are Not Second Class Citizens." They, and hundreds of thousands of workers and youth around the country refuse to accept what is now an all too well-known fact about bourgeois democracy— the workers. about bourgeois democracy—the workers, those who produce all the wealth, those who give their sweat and blood for a greedy few, are second—class citizens in this country.

greedy few, are second-class citizens in this country.

WORKERS RIGHTS, not phoney "human rights"! must mark a new turn in the mobilization of the American working class. For decades blacks have been waging a struggle in this country against the fact that they are second class citizens. All the "reforms" of bourgeois democracy have meant nothing; unemployment among black youth is at 70-80%!

Not only black liberation, but the liberation of the entire working class rests on the fight for Workers Democracy. First-class citizenship for the working class and the oppressed in this country is incompatible with the continuation of capitalism, even its "democratic" form.

As the iron ore workers have learned, as the miners and auto workers have

as the miners and auto workers have learned, this means that the fight of the

working class in their unions can no longer be restricted to "economic" questions. The struggle in the unions today is a political struggle of the working class for ALL OF ITS RIGHTS against the caption of the literature.

The jailing of the Stearns miners, the conviction of the Trenton Seven auto workers, the impending S. 1437 law in Congress prove that if the unions are to survive, they must launch a political offensive for the rights of the entire

American working class and oppressed.

Today the unions are not yet our weapons. Workers—we will remain second class citizens as long as we have this SECOND CLASS LEADERSHIP in the unions, the reactionary trade union bur-eaucracy, the lackeys of Carter and the Democratic Party in the workers move-

ment.

An offensive to turn the unions into weapons of the entire working class and the oppressed, to win full rights for the working class, is an offensive for a new, revolutionary leadership for the unions. American workers today can settle for nothing less than an all-out fight for freedom. And it is only revolutionaries who can lead this fight for freedom, those committed to abolishing this system which reduces the working class to Second Class citizenship.

New Haven, November 15-- There is probably nothing worse in the labor movement than for a worker to cross a picket line. The only thing worse is to try to give an excuse for this inexcusable act.

This is what Santiago Carrillo, the leader of the Stalinist Communist Party

of Spain tried to do as he crossed a picket line of striking Yale University workers in New Haven, Connecticut today, According to CBS Evening News Carrillo's first response was, "American unions are right-wing anyway."


This slanderous statement, typically

This slanderous statement, typically Stalinist, identifying the American working class with its reactionary leadership, is even more slanderous when it concerns the Yale strike. These cooks, maids and janitors have been engaged in a bitter six-week strike. The administration has refused to negotiate with them and gangs of right-wing students have been organized to attack the picket lines. The strike has gained national prominence. It is worth noting that Secretary

of Labor Ray Marshall refused to cross
the picket lines to give a speech, so did
US Senator George McGovern and Israeli
Social Democrat Golda Meir,
Now American workers have a more
practical idea of Stalinist "proletarian
internationalism" and "Euro-Communism." Carrillo is the first Western
Stalinist leader to be invited to the US
since World War II. He is here to lecture the US ruling class on the virtues
of "Euro-Communism"— the rejection
of the proletarian revolution in favor of
"peaceful coexistence" with capitalism.
Carrillo is LYING when he says;
"Spanish labor could never understand
how strikers could prevent someone fro.n
their own side from speaking." Both
Spanish and American workers have had
enough of this kind of "democracy" always used by right-wingers and capitalists to break strikes. Like the "right-towork laws" in the South that prohibit

Win the unions to the side of the revolution ____

By DAVID HEFFELFINGER On October 16th workers at the Chrysler Trenton Engine plant, Local #372 of the UAW, voted to take strike action to dethe voted to take strike action to do fend the leaders of a heat walkout at Trenton last summer. The workers were fired from their jobs for participation in the wildcat and were convicted of criminal contempt in early October by a Democratic Party judge, who the UAW but mocratic Party judge, who the UAW bur-eaucracy helped get elected.

This action on the part of the Trenton workers, as well as the heat wildcats

themselves in auto, show the central im-portance of the unions. They can either be used to organize the workers to extend their rights and conquests, and defend those they already have, or they can be used to elect Democratic Party judges who throw workers leaders in jail.

The fact that the Trenton workers took a stand against the so-called "impartial" proceedings of bourgeois justice and a Democratic Party judge to boot, is an example to the entire American working class that the Democratic Party and the class that the Democratic Party and the UAW bureaucracy which supports it cannot be trusted in any way to defend the rights of the workers. To the contrary, they are the ones who are leading the assault on the auto workers.

RWY DISCUSSIONS

How can this stand by the Trenton workers be the launching point of an offensive of all workers -- from the steel workers who have been hit with massive layoffs to the miners? How can the unions become the weapons of the working class in de-fiance of the traitors who now run them in the interest of the preservation of capital-ism? These were two of the important questions that were discussed by Ford River Rouge Stamping workers around the meet-ing of the Revolutionary Worker Youth. "One year of the auto contract and Carter,

The meeting clearly showed that these questions are important to be resolved because an entire generation of the working class in the United States has been brought up under conditions in which the unions were under the hegemony of a conserva-tive and cowardly leadership. Masses of young workers today view the unions as only one more institution looking for money, dues, and giving nothing in return but the bureaucratic run-around.

But these feelings toward the unions,

which amount to seeing them as institutions of the preservation of capitalism, rather than the reverse, are not the fault of the unions themselves but of the class collaboration of the trade union bureaucracy, and the regimentation of the internal life of the unions in order to defend this class collaboration.

IMPORTANCE OF WORKERS DEMOCRACY

Thus the fight for WORKERS DE-MOCRACY in the unions is key to winning MOCRACY in the unions is key to winning masses of workers to take up the struggle against the anti-worker plans of Carter and the ruling class he represents. This fight is to reclaim the unions as organizations of the working class -- free of special priviledges, businessmen parading as workers leaders, and free of the COURTS AND GOVERNMENT OF THE RULING CLASS.

The trade union bureaucracy tries to picture the conquests of the workers and the rights they still have left as gifts of benevolent American capitalism. Work-

benevolent American capitalism. Workers at Ford River Rouge remember the UAW's "Henry Ford, have a heart" campaign which ended in defeat for the workers. Countless other examples of such class treachery arise every day

The trade union bureaucracy begs the courts for small scraps in return for holding the unions in check, then cries "foul! when the courts throw strike leaders in jail. They elect a president with the weight and resources of the unions, Jimmy Carter, a representative of the capitalist backed Democractic Party, then retreat when this same president organizes an offersive against the workers. They can offensive against the workers. They run the union like it was a church or a school, then blame the workers for not coming to meetings.

SAVIORS OF THE BUREAUCRACY

Whether or not the bureaucracy can be defeated is not an academic question. Every strike raises this question. It is a life or death matter for the victory of the

The Stalinist American Communist Party and the centrist Socialist Workers Party, two of the largest claimants to the banner of revolution in the United States, hide behind the not-so-liberal wing of the unions in the face of the need to prepare the workers for the class battles

The American CP joined the trade union bureaucracy in cheering the gathering of several local-level bureaucrats of the UAW for a discussion on the "shorter work week." Some bureaucrats even went so far as to raise the demand, "a shorter work week with no cut in pay."
Forgetting the precise formulation of this demand, the important fact is that it, like every other demand that the bureau-cracy takes up, becomes another carn-

WHAT TO DO NEXT

No, the unions are not lost. The only means to rebuild them is through a political struggle against the class collaboration of the bureaucracy. This is above all a struggle for the leadership of the unions, for the workers to win WORKERS DEMOCRACY by ousting the traitors. It is a political line as well against the ruling class, the bureaucracy, "saviours" like Sadlowski and Patrick, and false "revolutionaries" who support them, and the working class, its strikes, its rights and conquests on the other. One side of the line means defeat, the other can rally millions of workers in the unions against the anti-worker attack of

unions against the anti-worker attack of the ruling class.

To do this it is necessary to build the Revolutionary Workers Faction in the UAW to wage a political fight against the bureautorate and their approximation. UAW to wage a political fight against the bureaucrats, and their supporters among the Maoists, Stalinists, and centrists. It is necessary to provide a leadership to the struggles of the auto workers, even before the last bureaucrat is kicked out of the UAW.

Only by reclaiming the unions in the United States, the only mass organizations of the working class, will it ever be possible to construct a mass Workers Party. But the building of the Workers

Party. But the building of the Workers Party, against the support of the trade union bureaucracy for the Democrats is a necessity as well for the unions from the point of view of combatting the false parties of the workers who fees an all parties.

Allan Bakke is a white student in California who charged "reverse discrimination" against the policy of the University of California Medical School in setting affirmative action quotas. The California Supreme Court, agreed with Bakke, said the affirmative action quotas admitting a certain number (16 in this case) of minority students was unconstitutional. The case is now before the US Supreme Court. If the California decision is upheld by the US Supreme Court, affirmative action programs throughout the country will be

This is a main lesson of the American and international working class; ONLY THE WORKING CLASS CAN DEFEND ITS OWN RIGHTS— independent of the bourgeoisie independent of the bourgeoisie.

erument on particularly black workers and students. It must be defeated. Of course, the "alternative" the Carter government proposes is "preferential layoffs". As well, it wishes to provide situations where students are fighting for the miniscule number of positions available in Law and Medical schools. This is the view of the Stalinists and particularly of the Socialist Workers Party: "Affirmative Action of Seniority," says one of the SWP pamphlets on the question.

These bourgeois supporters have no intention of even thinking about Jobs for All or Quality Education for All. They all of course support Carter and you can't support the working class at the same time. Or can you? The SWP also has no intention of fighting for jobs for all, and despite the sly winks, their "socialist miracle" will not come

SWP WANTS TO 'BRING PRESSURE TO BEAR'

It cannot be more clear. To develop "Bakke" as a movement which is "independent" from the WORKING CLASS but NOT from the bourgeoisie is to betray the gains black students and workers have won in their bitterly fought struggles. The policy of the leadership of the SWP is the same policy they implemented in Boston with "busing," It is utterly anti-working class, and pro-bourgeoisie. And all of the centrist organizations; the Spartacist League, the International Socialists, etc. are following the lead of the SWP. WORKERS DEMOCRACY OR "HUMAN

Young workers and militant students can

Young workers and militant students can see the government support to the Bakke case for what it is: a further attack by the government on blacks, students and workers. Everywhere in the US and around the world, the capitalists headed by US imperialism have increased the repression and attacks on youth and workers. In the unions, the bureaucrats physically attack the workers during strikes and they also attack their consciousness by telling them to "vote Democrat" for the "friends of labor." The government aggression through the police, the National Guard, through cut backs in education, unemployment and rising prices, AND Bakke, is their answer to the growing conflict between the classes. The way forward for students and workers in the face of this attack, including against Bakke, is to make their fight one for WORKERS DEMOCRACY, to demand through demonstrations and strikes, their democratic rights, not the "human rights" of Carter and his Stalinist and centrist supporters.

The centrist leaders of the SWP deny the class character the struggle against Bakke must have. In a recent editorial

The centrist leaders of the SWP deny the class character the struggle against Bakke must have. In a recent editorial in the MILITANT they pose the question: JOB BIAS OR JOBS? The editorial says that "Jobs for all" is what the union bureaucrats say in opposition to "affirmative action" when they have no intention of fighting for jobs for all. This is true.

The trade union bureaucracy is the hatchet man for the government in the unions and will never wage a fight for jobs of all workers when they stood silent while thousands of auto workers were laid off. But, why then, does the SWP join in a coalition with THESE SAME BUREAUCRATS and MORE members of the Democratic Party, to wage a "broad campaign" against the Bakke decision?

BECAUSE THE SWP HAS NO INTENTION OF FIGHTING FOR JOBS FOR ALL EITHER. Do they think that maybe Carter will decide to be a "nice guy" and allow affirmative action quotas to remain? Or maybe they think the courts upon which they wish to bring "pressure" are independent of Carter's wishes? Perhaps the SWP leadership doesn't think racism is as much a part of capitalism as racism is as much a part of capitalism as unemployment is.

Another recent article in the MILITANT on the cutbacks in education did not mention the Bakke case once. This is not an accident. For them the Bakke case is a "single issue," not a part of the fight against the government for jobs and education for all. The SWP wants to reform Carter through Allan Bakke reform Carter through Allan Bakke.

A REVOLUTIONARY STRUGGLE

S 1437: CAPITALIST 'BILL OF RIGHTS'

A new "Bill of Rights" is how Democrats and liberals describe the S.1437 bill now in Congress, also dubbed "Son of S.1,"
As a complete revision of the Federal criminal law, they claim it will bring fairness. Actually, this bill is meant to deprive the working class of any INDEPENDENT ACTIVITY. Therefore, the bill is aimed also at the organizations of the workers" the unions, and its parties. It lays the basis for banning demonstrations, assemblies, mass picketing, wildcat

assemblies, mass picketing, wildcat strikes, newspapers and organizations.

This law, while it cannot regulate the battles between the oppressed and the government can be a real weapon against the workers. It would legalize much of the present illegal actions of the government, and extend others. It can only be stopped through what it wants to prevent stopped through what it wants to prevent
-- the independent activity of the work-

WORKERS RIGHTS VS. CAPITALIST

This law is an excellent example of what "freedom" means for the workers in the heartland of imperialist "democracy." All of the imperialist's rights are strictly protected— the right to break unions, the right to search and seizure under the filmsiest pretext, the right to force you to testify, the right to use confessions obtained under torture. In a word, the right to protect their property within society in every way is completely inviolable. S. 1437 makes workers guilty until proven innocent. The capitalists

can lock the doors of their factory and deprive thousands of the right to live. If the workers set up a picket to stop scabs they're guilty of extortion! Youth protesting unemployment, especially under slogans like JOBS FOR ALL and WORKERS CONTROL OF PRODUCTION could appear to "create the danger of damage to property" and mass arrests would follow.

erty" and mass arrests would follow.

Such rights as freedom of assembly and speech already hollow, would be lifted out of the books. Any protests against capitalist violence such as against trials or on the military bases will all be declared illegal.

Any activity can be criminal if it "in-terferes" with the defense of the US."

Any strike, demonstration, any NEWS-PAPER, OR ORGANIZATION, could fit under that category. They've already used similar laws against the Teamsters, hospital workers, and now would be able to move against miners, auto and steel-workers for "disrupting our energy supp-lies, "and hurting the economy."

THE VOORHIS ACT

S. 1437 allows capitalists to conspire, fixing prices around the globe, but no US worker can belong to any international workers organization without registering the organization, and everything about it, with the government! This law, the Voorhis Act is directed particularly against the Fourth International and the Revolutionary Youth International, the only international party and youth organization of the working class.

The workers struggle against S. 1437 must include the demand to ABOLISH THE VOORHIS ACT, for we will not defeat US imperialism at home if we cannot fight together with our brothers and sisters overseas who fight it as well. The struggle against the Voorhis Act is particularly important today as the government, with the trade union bureaucracy, is gearing up a vicious nationalist campaign to blame unemployment, inflation, short energy supplies, on the Japanese and German steelworkers, on the Palestinians, and Arabs,

HOW TO STOP S. 1437

This bill can only be defeated as part of the offensive by the workers against the counter-revolution launched by the bourgeoisie. The "sister" organization of the SWP in France, the LCR, now says that the affair" is closed since their counter-commission has reached its "conclusions. The SWP was always silent about their support to the slanders. They are quiet for one reason; in order to be able to renew the slanders and re-attack the proletarian policy of the Trotskyist Organization. Under the guise of the "Varga Affair" the SWP tries to hide the policy of the To from their militants.

But the Trotskyist Organization is armed... armed with the TRUTH about the Stalinist nature of the slanders, who they aid and what they hide... we will use the WHITE BOOK AS A WEAPON.

STALINIST SLANDERS ARE NOT NEW

Although not of the same magnitude or quality as the Stalinist terror of the bureaucracy in the USSR and Eastern Europe, the US bourgeoisie, and their Stalinist and centrist supporters have similar methods with which American workers are familiar.

When the Trotskyists of the Left Opposition were first expelled from the Communist Party in 1928, for defending the Russian Revolution against the be trayal of Stalin, the slanders began. James Cannon, the Trotskyists' leader was an "agent of imperialism" and anyone in the CP who spoke out against the expulsions of the Trotskyists was also expelled.

expelled.

The basis for the slanders against the Fourth International in the US and around the world are the same; to turn attention away from those who are fighting to develop the gains of the Russian Revolution, of October, those who are exposing, in the struggles of the workers, the help that Stalinism gives to imperialism. And today, the slanders of the OCI and the refusal of the SWP to call them slanders serves the same function, as a substitute for political combat.

THE SPARTACIST LEAGUE

The US Spartacist League, which thinks the Fourth International is "dead," initiated the pseudo-Commission in the

name of "objectivity" and "Spartacist League principles," They said that it was impermissible for the "accused" to sit on the commission, as it would not then be "objective." With all their so-called principles, the petty bourgeois SL cannot recognize a Stalinist slander. As for "objectivity," the Spartacists did the workers movement the favor of

As for "objectivity," the Spartacists did the workers movement the favor of publishing the "results"—that Michel Varga was a "highly dubious figure"—over a year before the pseudo-Commission even met! Some "objectivity"!

If the Fourth International is dead, as these miserable centrists claim, no wonder they show no principles in attacking it. In Spain they said that the leadership of the PORE was responsible for the arrests of six members by the Franco government. They said that any party which refused to accept the clandestinity imposed by the Franco regime, and which openly fought to mobilize the Spanish working class for its own government was "provocative." By, the way, they have never said anything similar about any other organization in Spain, including the centuists who suffered many more arrests and saved their comments for a typically choice Spartacist moment—when our militants were being tortured in Franco's jails!

The SL made a similar accusation against the militants of the Trotskyist Organization at Ford River Rouge in Detroit. They said that our call for the massive distribution of communist literature against the company's ban on such literature was a "provocation."

And as well they picked the right moment to make their criticism—when two of our militants were arrested for supposedly being on Ford's property. And of course they refused to defend them.

To put it bluntly, this organization is a "rest exercise of the supposed to defend them.

To put it bluntly, this organization is a "rat group"—living off the crumbs of the Fourth International and whatever scraps the imperialists, the Stalinist police, the fascists—it doesn't matter to them—throw their way.

In #617 of the paper, INFORMATIONS OUVRIERES, organ of the Federation of Workers Committees of Alliance, is published a long article, unsigned, titled "Provocations in the Fourth International." This slanderous article, directed against Michel Varga, member of the Revolutionary Socialist League of Hungary, section of the International League/Rebuilder of the Fourth International, is a true police action whose methods are well known to all those who are fighting against Stalinism. Bela Szasz: Organizer of the Hungarian Communist Party in illegality, in the 20's. One of the leaders of the movement at the university. It was him, who in 1930 recruited Laszlo Rajk to the party. After years of illegal combat, he was active for several years in Western Europe. Returned to Hungary in 1945. Arrested with Laszlo Rajk and his comrades, Bela Szasz was destined by the police apparatus of Rakosi to play a prime role in the Rajk trials in 1953. Despite several months of uninterrupted tortures, forced to stand up all day and night, electro-shocks, bones broken, etc., he was the only one accused to never confess. He was condemned to 10 years in prison. In September of 1956, during the official burial of Rajk, which was transformed into a demonstration of several hundreds of thousands of people, and the prelude to the revolution, it was Bela Szasz who was the main speaker, accusing the bureaucracy. After the revolution was defeated he rejected offers of compromise on the part of Kadar and chose exile. Why the Fourth International remains illegal in Spain

As part of his shameful attempt to justify scabbing on the Yale University workers' strike, Santiago Carrillo, the 'leader of the Spanish Communist Party remarked to the NEW YORK TIMES; "The American labor movement has done nothing to promote democracy in Spain." promote democracy in Spain."

In order to answer this slander, not

In order to answer this slander, not only of the American labor movement, but of the word, "democracy," itself it is necessary first of all to ask: What has Santiago Carrillo done to promote democracy in Spain, what does he mean by 'democracy'? Secondly, as part of answering this question, it is necessary to ask, What is Carrillo doing in the US, visiting Yale, Harvard and Johns Hopkins universities? And what is his Social Democratically. Felipe Gonzalez doing in the US ic ally, Felipe Gonzalez doing in the US at the same time, visiting in Washington with Vice President Mondale and Secretary of State Vance?

of State Vance?

They are both "promoting democracy in Spain." Precisely. Their version of "democracy." A version of "democracy" that they are putting into practice with great regularity in Spain. Carter's "democracy." Mondale's "democracy."

But not the US or Spanish working class' democracy.

democracy.

It is obvious to everyone, for example, when the Shah of Iran visits Washington. He is there to get support for his bloody dictatorship. But maybe it isn't so obvious when Carrillo, the first leader of a Western European Communist Party since World War II to come to the US, arrives. After all, isn't the US government opposed to "communism?" Isn't it a victory for "human rights" that Carrillo was allowed into the US.

WELL-BEATEN PATH

But Carrillo travelled a well-beaten path to arrive in the United States. Just before coming to the US, Carrillo, along with Felipe Gonzalzz, the head of the Spanish Socialist Party, met in the Moncloa Palace in Madrid and with the head of the Spanish Government, Suarez, with the head of the Spanish police, Martin Villa, with the head of the fascist party, Fraga, signed the Pact of Moncloa which is an agreement to betray the working class in Spain. (See Statement of the Political Bureau of the PORE). All in the name of "democracy."

Carrillo's well-beaten path is even longer than this. The Moncloa Pact was just the conclusion. Since the death of Franco, the Spanish Communist Party, under Carrillo's leadership, has consistently supported the survival of the Francoist monarchy and its police apparatus against the struggle of the working masses to establish their own government. The first act of the "legal" Spanish CP was to

against the struggle of the working masses to establish their own government. The first act of the "legal" Spanish CP was to hold a conference under the flag of Franco! It is the Spanish CP which is above all responsible for the fact that the farce of the Cortes last June was set up

farce of the Cortes last June was set up against the working class.

But Carrillo had to take another journey before being allowed in the US to "promote democracy." After saying in Spain, on the 60th anniversary of the Russian Revolution, "there are no Winter Palaces to take here," i.e. that there is no reason to organize a workers' revolution in Spain, Carrillo took a trip. He went to Moscow, where on the 60th anniversay of the Russian Revolution, after saying that it was impossible in Spain, paid homage to the Stalinist bureaucracy of the Kremlin. This is the "dictatorship of the proletariat" Carrillo was saying, this this is what you'll get if you storm Winter Palaces! Palaces!

And the Kremlin bureaucracy made
Carrillo's passage through the US Customs
a little easier by refusing to allow him to
speak in Moscow. Just to prove to Carter, Harvard and Yale that he was "clean,"

ONLY THE FOURTH INTERNATIONAL

Just like in the US there has been only one party which has opposed and led a consistent fight against Carter's "human rights," exposing the farce of bourgeois

democracy in the US, our party, so in Spain, it has been only the Partido Obsero Revolucionario, the Spanish Section of the Fourth International which has fought against the "democracy" of Carrillo and Gonzalez, for Workers Democracy in Spain - a Workers and Peasants Govern

It is for this reason that the PORE remains illegal and was in fact the first workers party to be declared illegal in Spain after the elections to the Cortes. A fact no American worker will ever find by reading either the press of the Stalinists or the centrists, particularly those who falsely claim the Fourth International in the US!

The Pork was declared filegal because it was one of the few workers parties in Spain to oppose the farce of the elections to the phoney Cortes last June and the ONLY party to mobilize the working class against it, calling for a boycott and organizing markers on the prisons to free the

political prisoners.

It was the only workers party to refuse to accept the conditions of the monarchy for legalization—acceptance of the elections to the Cortes, acceptance of the Suarez government as the "constitutional" government in Spain, and abandonment of the proletarian revolution and any ties to an international party. For this, and for massively ORGANIZING the Spanish working class behind this policy, the PORE remains illegal. The Moncloa Pact is PROOF that the

So spoke Kenneth Cockrel, just elected to the Detroit City Council in an interview in the DETROIT FREE PRESS entitled: Marxist Councilman Urges Move to Left." In the interview, Cockrel proved that he was no Marxist and indeed that nothing he was proposing had any resemblance to revolution: "So, I'm not calling for anything that's, like, farfetched." said Cockrel

Cockrel had to go to great lengths to reassure the Detroit bourgeoisie that he had nothing to do with "Petrograd," the October Revolution or with any revolution. because, unfortunately, he is still associated in the minds of the Detroit working class with revolution, with Marxism, and this was the reason he was able to be

elected.

Cockrel was the only candidate not Cockrel was the only candidate not supported by the UAW or AFL-CIO bureaucracy and the official Democratic Party apparatus to be elected to the City Council. His election and relatively strong showing was above all due to the reputation he gained in Detroit in the late 60's and early 70's as a radical

In particular, Cockrel was known for his defense of James Johnson, a Chrysler worker who shot and killed three men at Chrysler's Jefferson Avenue plant after being unjustly fired from his job. Johnson was found innocent by reason of insanity, because Cockrel was able to demonstrate to the jury, that it was Chrysler and the US Government (Johnson was a Vietnam veteran) who was responsible for and the US Government (Johnson was a Vietnam veteran) who was responsible for Johnson's anger, Cockrel also defended Hayward Brown who was acquitted of shooting three Detroit STRESS officers, a

shooting three Detroit STRESS officers, a special police unit set up to terrorize the black community in Detroit.

These were victories for the entire working class movement in Detroit, they were not Cockrel's personal victories. While we disagree with the policies of DRUM and the League of Revolutionary Black Workers, they were attempts to organize young black workers in the auto industry in a revolutionary direction, against the UAW bureaucracy, against support to the Democratic Party and those allied with it. But for Cockrel and some of the other leaders of Drum and the League, the revolutionary fight of the young, black workers in Detroit simply became a steppingstone for opportunism. Unable to truly

ers in Detroit simply became a steppingstone for opportunism. Unable to truly
organize young black or white workers on
a lasting basis because of their own lack
of a clear policy and leadership, Cockrel
and others concluded that working class
revolution was impossible, that reform
was the only answer.

Thus, Cockrel now finds himself the
leading proponent of the policy that
DRUM and the League began by fightingthe Stalinist policy of "reform" of the
Democratic Party, "the liberal-laborblack alliance" to hold back the mobilization of the working class and keep the
stranglehold of the Democratic Party over
the workers.

It is not an accident, that in another country thousands of miles away, another workers' "leader," Santiago Carrillo of the Spantia Communist Patty said: "here there are no Winter Palaces to take," another laughing community to the October there are no Winter Palaces to take," another laughing comment at the October Revolution in Petrograd in 1917. Carrillo said this as he signed a pact with the Francoist government, with the fascist parties, to hold back the mobilization of the working class and to organize the repression of the revolutionaries in Spain.

Cockrel has made a similar pact, not as formal, but just as Stalinist. His place in the manuevers of the Democratic Party and the UAW bureaucracy in return for his promise for "no Petrograds," for keeping the working class tied to the capitalist system.

ing the working class tied to the capitalist system.

The US bourgeoisie is now everywhere hailing Coleman Young's election in Detroit as a great victory. Young is now being elaimed as "the foremost black politician in the country." Finally, they think they have found a black politician who can control the working class.

Cockrel is part of this scheme, "now there is even a "marxist" voice in Detroit, they say. But in reality the bourgeoisie and all of its hangers on are scared. The remark about "Petrograd" was not accidental. Everyone knows that if there is a Petrograd in the US it is Detroit, the center of the nation's most important industry, the home of the most militant working class.

Cockrel and Coleman Young have come out of the woodwork in recent years because a Petrograd is indeed being pre-

Cockrel and Coleman Young have come out of the woodwork in recent years be-cause a Petrograd is indeed being pre-pared by the workers in Detroit. A Petrograd that at all costs the Democratic Party and their Stalinist allies in the American Communist Party are prepared to prevent. And just like Petrograd of 1917, the Detroit Petrograd will succeed by exposing and breaking with the Mensheviks, like Kenneth Cockrel who stand in the way of its victory. way of its victory.

WORKERS RIGHTS IN THE COAL FIELDS-DEMOCRACY IN THE UMW

A decisive battle for the US working class is being prepared in the coalfields today. The current contract of the United Mineworkers (UMW) with the coal companies expires on December 6th. The very existence of the UMW is at

the very existence of the UMW is at stake in this battle.

The coal bosses have said this openly. Their head negotiator, Joseph Brennan last month stated: "The question is, whether or not a proud labor union will meet in good faith bargaining with an industry and teacher forces." meet in good faith bargaining with an industry and together forge a contract that will permit us to grow together, or whether we will fail, and therefore, see the DECLINE AND POSSIBLE EXTINCTION (our emphasis) of the United Mineworkers of America as a force in the national collective bargaining process."

The capitalist courts, their police and their fascist company goons have stated this openly as well. Eleven UMW militants were just sent to jail by a judge in Stearns, Kentucky and 68 others given suspended sentences after the state police but ally attacked a picket line. brutally attacked a picket line.

The Carter government has stated this openly also. Increased production of coal is at the heart of Carter's "energy program." That is, increased profits for the coal bosses and deteriorating working and health conditions for the

Every miner knows that this is a concerted attempt to smash a powerful mobilization of the mineworkers that has been sweeping the mines in the last years -- repeated national wildcat strikes, violent and bloody battles for the right to unionize, confrontations with the UMW bureaucracy. And every class conscious worker in the US knows that if the government, the courts and the the government, the courts and the bosses can destroy the UMW the entire US working class will feel the blow. It will be a massive defeat.

THE MINERS MUST NOT BE DE-

THE MINERS MUST NOT BE DE-FEATED! Carter and the bourgeoisie have their "human rights." The fight of the miners is for the most basic rights of the working class. Unrealistic? Miners, beware of those who talk to you in the coalfields of "realism." You know these "realists" -- who have held back all of your struggles, who oppose the wildcat strikes, who do nothing to help the Stearns miners or the miners in Harlan County who want to organize. These "realists" are the bureaucrats, who have held back all of the struggles of the miners. They are responsible as well for the attack on the UMW today.

There can be no workers rights in the There can be no workers rights in the coalfields, no battle against the bosses and the government, without Workers Democracy in the UMW. And there can be no Workers Democracy without throwing out the present leadership and electing a new, revolutionary leadership for the UMW. Nothing can come out of the present leadership of the UMW, nothing has come out of them for over five years. And now, on the eye of the strike, at

Patrick would have been buried months ago, and in fact was buried politically by the militant miners in the UMW after they saw him come out time and time again against their wildcats, after refusing them their right to strike over safety.

Go very slow. Go very careful."
Of course, we know why Patrick wants to go "slow" in changing the leadership.
He's a bureaucrat. And he wants a "labor party" led by bureaucrats. But why do the bureaucrats, the Stalinists and the

"the main enemy is the company?"
Workers never say this. They know Workers never say this. They know that when you go into battle the question of who is leading the battle is the most important question. What's the importance of knowing who the "main enemy" is, if there is a leadership that cannot win? Or can the workers win spontaneously?

The centrists and Stalinists say this because they support the present leader-ship which the young workers are to-tally dissatisfied with and disgusted with. We say that the only way forward, the only way to win real WORKERS DEMOC-RACY in the UMW and real workers rights in the coalfields is with a revolutionary leadership. Beware of those who say this is "unrealistic." It is "unrealistic" to them because they offer no fight against the most "realistic" question in front of the UMW today -- the destruction of the union.

American workers should not be deceived by the theatrical show acted out in Washington with the Israeli regime and its Zionist lackeys in the US, about a supposed "dispute" between US imperialism and Zionism. It only is a manuever to hide from the US working class the crimes of Zionism.

This latest bombing was not an accident. It is the "practical" side to the counter-revolutionary settlement now being set up by US imperialism and the Stalinist bureaucracy of the Kremlin to crush the Palestinians and the working and oppressed masses throughout the Middle East.
