# NORTHERN SPAIN SEETHING; UNIONS JOIN IN REVOLT

Bayonne. France, Aug. 3.—Reliable news regarding the situation in Spain received here this morning from San Sebastian represents conditions as grave throughout the northern part of the country, where all the trade unions have given notice of the beginning of a general strike today. The government has seized telegraph and telephone wires in the affected provinces to prevent the leaders of the strike movement from communicating with one another. Transmission of newstance dispatches has been stopped, forcing a suspension of a majority of the journals.



Revelations showing up the inside workings of the wheels of graft in the police department of Chicago are expected from the fight just started by his family at 325 Washburne avenue, who has been driven to seek a refuge in all the corners of the world for the blackmailing schemes of the Chicago police during the last thirteen



"The commissioners are taking up the roadway, which is asphalt in good condition from Twelfth street north. Many thousands of dollars worth of good material is wasted because the raik commissioners des ratto widen the roadway and change the grade of the virest. They could have waited until the street was worn out.

"In videning the sidewal's south from Twelfth street they destioned in commissioners are taking up

Twelfth street they destroyed the lawns adding all the space to the side-walk, making it needlessiy wide, whereas they could have added it to the street which is now too narrow according to their own admissions.
