VIOLENCE LET LOOSE BY JANATA PARTY GOVERNMENT TO SUPPRESS LEGITIMATE DEMOCRATIC MOVEMENTS

—The Same Old Heritage Carried Forward

To bring about restoration of democratic rights and civil liberties, if voted to power, was one of the Janata Party's foremost promises to the people in the last election battle. And since their take over of power at the centre, they never tire in eulogising the extent of democratic rights and freedom they have restored sparing no efforts to convince people of its truth, but the manner in which they suppress all legitimate peoples' movements tells a different story In their six month's rule the Janata Government has let loose a wave of violence in suppression of people's rights. Thus, in Rajahara Mines (under Bhilai Steel Project) the legitimate demands of the workers for some bonus at par with workers of the steel plant was most brutally suppressed and their trade Union leader arrested. When the workers assembled in protest and demanded the release of their leader the police started firing at random causing a real massacre. The actual numbers of killings were much higher than 13 as reported in the press, which made the whole massacre appear as a sequel to an armed Naxalite action.

In parliament the Home Minister defended this police atrocity in the name of law and order. In the nature of their ruths is no difference whatsoever with the former regime. Similar police atrocities took place in Bihar, too. On August 24, the workers of Jitpur Colliery of Indian Iron and Steel Company peacefully assembled in front of the manager's office and demanded that the management meet their long-standing grievances and make payment of outstanding dues to them as directed by the RLC which the management had continuously refused to do. In answer to their legitimate just demands the workers were most brutally lathi charged by CISF men and even fired upon resulting in the death of a worker. Another incident, in outrageous violation of all democratic norms and ways happened in Bokaro nature of police oppression; Steel City where the workers of Hindustan Steel Works Construction Ltd. had been agitating for the implementation of the decision of the Steel Wage Board in vain for more than a month. On August 26, the management ostensibly for conducting negotiations sent for some workers' representatives only to have them arres-

ted. Next day when the

workers peacefully demonstrated in front of the administrative building and asked for the release of their arrested leaders lessness and savagery there the CRP began lathi charge and fired on the workers killing six, injuring a great number and arresting more than a hundred workers.

> Even the public is not spared from this savage onslaught and brutal killings. In Barahiya (Monghyr district) on September 2, police opened fire on a crowd of people, members of the public including local students, who staged a peaceful protest demonstration at police inaction, since the police had failed to take action against the culprits who had committed an unnatural offence on a schoolboy. According to the Economic Times four persons died on the spot and three in hospital later. There are countless other incidents revealing the real to mention but a few-Faridabad, Ghaziabad, UP. Modinagar, Sonapet-in these belts ruthless suppression of the workers' legitimate demands followed in quick succession.

Statement of Secretary Assam State Committee, SUCI

Com. Asit Bhattachars yya, Secretary of the Assam State Committee of SUCI has released the following statement to the Press:-

"An extended meeting of the Assam State Committee of the SUCI was held at the Party Office at Gauhati from 16th to 18th September '77. The meeting expressed grave concern about the famine conditions created by devastating floods in different parts of the state and strongly demanded regular supply of sufficient quantity of gratuitous relief including baby foods; arrangement of test relief works for the agricultural labourers, free distribution of seeds and seedlings to the food affected peasants all over the state, and adequate monetary grant for purchasing cattle and reconstructing houses to

the needy flood stricken people.

The Central Committee of the SUCI strongly feels that powerful mass movements must immediately be organised throughout the country for effective solution of the (a) Problem of alarming price rise, (b) Acute unemployment problem, (c) Restoration and extension of democratic rights and release of all categories of political prisoners.

The State Committee of the Party has, therefore, decided to launch forthwith, a state-wide vigorous compaign demanding (1) Introduction of all-out State Trading in foodgrains and other essential commodities, (2) Provision of jobs to jobless persons or otherwise provision of

PROVISIONS OF "EMERGENCY" APPLIED TO SUPERSEDE THE BOARD OF SECONDARY EDUCATION WEST BENGAL The 'Left Front' Govern-

The 'Left Front' Government on September 14 last superseded the West Bengal Board of Secondary Education and appointed Mr. Satyapriya Roy of the CPI(M), a former United Front Minister for Education, its administrator. In a notification issued in Calcutta, the State Government held the superseded Board responsible for the failure to protect the interest and security of the teachers who had been prevented from taking up their duties despite 'necessary directions'. The Board had also failed to approve in time the elected managing committees and had allowed schools to function without these committees or with 'invalid' ones, the notification alleged. The notification also mentioned charges like abuse of power, misuse of fund, negligence in conducting examination and publishing results etc. etc.

against the Board we fully subscribe to them. As a matter of fact Comrade Debaprasad Sarkar, the leader of the SUCI group in West Bengal Assembly raised those very charges while he was speaking on the budget demand on education on 12th September last; but unfortunately Comrade Sarkar did not get any reply or assurance from the government regarding the remedial measures against these issues on that day. But on 14th September last the Board was superseded in a manner which can be only called conspiratorial, on the plea of removing these charges of corruption and maladministration showing scant regard to democratic norms. From newspaper reports and also from the statements of some Ministers as published in newspapers it seems that other constituents of the 'Left Front' were not taken into confidence in taking the decision of the supersession of the Board. A report published in the Statesman, dated September 16, '77 states: "The West Bengal Minister for Higher Education, Mr. Shambhu Ghosh said, in reply to a reporter's question in Calcutta on Thursday that the decision to supersede the West Bengal Board of Secondary Education had not been discussed by the cabinet before it was announced by the Minister for School Education, Mr.

As regards the charges

Partha Dey, in the Assembly on Wednesday. He refused to comment when asked whether he felt this should have been discussed in the cabinet. Mr. Ghosh agreed, however, that the issue was quite a serious one.

"The Minister said that he was not aware whether the matter had been discussed in the Left Front committee meeting since some other representatives of his party (Forward Bloc) attended the meeting. Mr. Ghosh also delcined to say whether he was happy with the decision".

But it is learnt from a subsequent report published in the Statesman dated 19th September 1977, that the decision to supersede the Board was taken by the 'Left Front' and there was no rift in 'Left Front' on any issue. What ever might be the case, a public controversy did surface because of the statements of some Ministers; however the constituents of the 'Left Front' know best the truth about it. But what worries us most is the manner adopted in superseding the Board. When the state government took this measure the Assembly was in session. So it was expected that the ruling party would take the legislature into confidence in taking such an action. At least ethics and minimum democratic norms demand such an approach from any democratic government.

ment in West Bengal declared on assumption of office that it would not run the administration from the Writers' Building but would depend on the democratic opinion of the masses in framing and implementing its policies. But in superseding the West Bengal Board of Secondary Education, the Minister for School Education, let alone eliciting democratic opinion of the students, teachers and other sections of the democratic masses, even by passed the legislature. What is worse is that the state government led by the CPI(M) took recourse to a black law which was passed by the Assembly in February last with help hated Emergency in spite of the fact that the CPI(M) is committed to undo all undemocratic measures including the 42nd amendment of the constitution. The CPI(M), along with others, just before the election was showering promises to the electorate to do all in its power to scrap the hated 42nd amendment in its totality. But when the opposition including our party, the SUCI staged a walk out from the Assembly in protest against the undemocratic act of the government by resorting to the hated laws passed under the Emergency, Sri Jyoti Basu, the Chief Minister defended his action by saying, "Was not the Central Government making use of the laws passed during the Emergency?" What an argument! Does Sri Basu want to mean that the action of the state government becomes justified as the central government is also resorting to the same undemocratic measures? We know that the leaders of the Janata party at the centre are discussing with the Congress in order to retain certain so called 'good things' of the 42nd amendment and it seems from the argument of Sri Jyoti Basu that the CPI(M)

also share the same view about those 'good things' of Emergency, which the Janata Party discovered after the election.

History is replete with instances of the Congress Government taking recourse to such undemocratic measures with the ulterior motive of serving its petty party interest. At that time all democratic forces including the CPI(M) condemned those heinous moves of the Congress Government. But what is sauce for the gander is sauce for the goose too. The supersession of the Board bypassing the legis= lature by the present 'Left Front' government therefore, equilly undemocratic and deserves severest condemnation. It is apparent that the CPI(M) leadership opposed the Congress in all their undemocratic measures not from an angle of upholding democratic norms; they opposed the Congress as they were being deprived of a fair share of the loaves and fishes. The CPI(M) leadership too does not hesitate to trample democratic norms whenever their petty sectarian party interest demands it.

The Board of Secondary Education has been superseded with the expressed intention of removing corruption. But how can the corruption be wiped out by taking such an administrative measure only and that too in a very surreptitious manner? Is it possible to remove corruption without mobilising public opinion and without relying on the democratic movement? We have seen that the Central Government took over the Viswavarati University with the inten* tion of removing corruption and mismanagement: but nothing tangible has been achieved. It is only by conducting serious ideological struggle and releasing cultural movement backed by administrative measure. whenever necessary that the corruption can be removed. But it is sad that no other party excepting the SUCI has ever come forward with the task of cultural movement.

It is known to all that

during the period of the Congress misrule most of the governing bodies and the managing committees of the acadamic institutions were most undemocratically constituted. As most of the educational institutions are financially dependent on the government, most unjust and wrongful pressure was created over the authorities of the institus tions by taking recourse to different heinous ways and means. The Congress most undemocratically inducted their own men in constitue ting these managing committees. So it is necessary to undo the wrong and arbitary actions of the previous Congress regime and restore democratic atmosphere in educational institutions. But if the 'Left Front' government led by CPI(M) replaces the men of the Congress Party by their own men without going through the democratic process of holding elections to constitute the managing committee of different institutions and without the most urgent task of democratising the Board of Secondary Education itself, then it would be the most unjust and highly condemnable action. In this connection it must be mentioned that while the government must bear the full financial responsibility of the educational institutions, it at the same time, must refrain from curtailing the autonomy of these institutions. Under the existing capitalist system any governmental control over the educational institutions will invariably lead to regimentation of thought to the benefit of the ruling class no matter which party runs the government. So in order keep the education system free from regimentation the educational institutions must be kept free from governmental control and their autonomy must be extended further.

Lastly we appeal to all persons interested in education to think over the entire issue in an unbiased way so that a correct approach emerges through debate and discussion and the cause of education and the banner of democracy is upheld.

WHAT WERE THEIR PROMISES

The CPI(M) leaders made many promises to the people during their campaign before the election to the West Bengal Assembly. Those promises include "jobs for all able bodied persons and social insurance and unemployment allowance for the unemployed", "reduction of taxes on essential articles and their proper distribution". "Fixing of price of essential articles at national state level and effective penal action against arbitrary raising of prices by monopolists, hoarders and blackmarketeers", economic regeneration of the state, opening of closed factories etc. etc. The CPI(M) and its allies have come to governmental power.

How far, people's results, now at this stageverdict has worked and what was the role of monopoly houses—bureau tion of economy, jobs for cracy-press barons combine in determining actually the election results, though a serious question, is not the subject of discussion here. Here we want to examine, how far sincere has been this government in meeting its commitments to the people.

Nobody expected any miracle to happen nor anything 'revolutionary' was expected of a government which is nothing but the "caretaker of the bourgeoisie", "an operator of the bourgeois state machine". But what the people definitely expected of the government was that at least they would reflect prospeople attitude and would take those concrete steps and measures which are within their powers and which any government having a modicum of pro-people attitude should normally do.

The 'left front' in fact detailed out their programme of 36-points and in the governor's speech presented to the Assembly it was assured that the government would be guided by the 36-point programme. Chief Minister Jyoti Basu told the Assembly that they would not bluff the people like the previous Congress ministry but would sincerely implement the 36 point programme on which they fought the election and as such stand committed to the people.

But what is the picture today? How far sincere has been the government in honouring its commitment? We do not ask of them to show tangible

results, now at this stage. Nor do we refer to their promises of like regeneration of economy, jobs for opening of factories etc. Let them try if they can. But what about taking "penal action against arbitrary raising of prices by monopolists, hoarders and blackmarketeers"? Do they think there is no speculative price increases almost daily and that the situation has not far over-stepped people's patience? In fact prices of all the essential commodities are increasing by leaps and bounds and people do not know what price they will have to pay the next day for essential items of consumption. This shows that speculators, hoarders a n d blackmarketeers, this tribe of anti-socials have had a real field day. People are feeling helpless and expect of the government which is not a Congress Government but a 'Left Government' to take stern measures against these enemies of the people in conformity with their electoral promises. But what has been the response of the government to this dire misery of the people? The response of the government has been quite contrary to people's expectation and the electoral promises. In fact the 'left front' spokesmen are also admitting this fact but the point is what concrete steps they are taking to protect the people? Rather, whatever might have been the promises and the assurances of sincerity, the ministers and the spokesmen of the front, more specifically, both the Chief Minister

Jyoti Basu and the

chairman of the front Promode Dasgupta started singing a different tune immediately after assumption of office. They started telling the people that everything about their promises would depend on the centre. They mean to say that the ministry has nothing to do except placing orders to the centre for what the people of this state want them to do.

If this is political honesty then people are surely within their rights to ask a few questions to them. They will ask, if it is true that the State Government has nothing to do with the hoarders and speculators who are holding the people at ransom and are freely robbing them of their last paise with impunity then since when this realisation of truth dawned on the leaders? Is it after actual enjoyment of ministerial privileges or the privileges of a ruling party in the administration? Why not before it? Why not at the time of drafting the 36-point programme, at the time of electioneering? Then again, is it not a fact that these parties who are now in the government did actually tell the people a different thing when they asked them, as parties in the opposition, to organise against the anti-people food and price policies of the previous State Governments? Is it not a fact that they led many moves ments in the past against the pro-monopolist and pro-speculator food policies of Profulla Sen and Siddhartha Roy? Why then did they mislead the people? Why then they demanded of the state governments, again and again, stern measures against hoarders and profiteers? When the Congress governments because of their link with those enemies of the people bungled the issues, took weak-kneed policies why then the 'leftist' leaders demanded of them to get out? Will the people be wrong if they say that if they have nothing to do then they should come

down from the ministry and join in mighty movement against these enemies of the people? Will it not save the precious public money spent on the state ministry and bring the centre direct to the people? And finally, will not the people be justifid to say that telling one thing before the election to get votes and then a complete disowing of of that after coming to the government, though not a new experience, is not political honesty by any definition?

But a question still remains that does CPI (M) leaders think that a state government has nothing to do with the hoarders and speculators? Why wedoubt this? Because we see that Sri B. T. Ranadive, a member of the Polit Bureau of that party is accusing the Kerala Government (where they are not in the ministry), of pursuing antipeople policy in not curbing the dishonest traders. In his speechat the General Council of CITU, Sri Ranadive says: "In Kerala, during the Emergency, the economic and employment situation worsened beyond measures. The Coir, Cashew, Bidi and handloom industries threw thouands out of

"The acute unemployment situation led to illegal migration, thousands seeking jobs abroad... virtually accepting the status of bonded labour.

"The wretched Coalition Government would not lift its finger to give relief to the workers. Much relief can be given if only the government undertakes monopoly procurement of coir husk and ensures its equitable distribution. But this would affect the enormous profits of the merchants. How can the coalition agree to this?

So, Ranadive thinks that 'much relief can be given' to the people against the operators of speculative price manipulation of articles if the State Government 'undertakes monopoly procurement'

and 'ensures its equitable distribution'. And the Kerala Government certainly can not take the plea that it depends on the centre. If it does, it will be a cover for not 'affecting the enormons profits of the merchants'. But the point is what is true for Kerala is equally true for any other State Government particularly when it is a government run by a party having this piece of wisdom of Mr. Ranadiye. Why then the CPI(M) led government is pleading its inability to take any such measures as would affect the enormous profits of the merchants?' How is it that the West Bengal Government not to speak of taking any measure against the speculators and black marketeers in essential aricles has completely failed to protect jute growers by ensuring monopoly procurement of jute at a remunerative price although that was also one of the electoral promises? What would Mr. Ranadive say?

Then again, when they are saying that nothing can be done on the food and essential commodities front, Sri Jyoti Basu, himself says a different thing when it is an occasion of an interview with the Blitz-editor having an all-India publicity. The editor of that journal reports thus:

'In an interview with Mr. Karanjia, Blitzeditor Mr. Jyoti Basu said, even if the union government failed to announce its programme and put it into practice, the State Government would devote all its efforts to curb prices. Mr. Basu agreed with the Blitz-editor that what was needed, 'special courts to hold summary trials and mete out drastic punishments to economic criminals.' He was aware that a small cotarie of wholesellers controlled the commodity market. 'These people will be rounded up, if necessary, by issuing ordinances or by introducing prompt legislative measures in the Assembly now in sessions,

and put up for trial because 'we can hardly afford to be quiet in a situation like this."

(Blitz-Sept. 10, '77) Heroic words no doubt: But people wanted them to be heroic not in rhetorics but in concrete deeds. Otherwise these rhetorics too, will go the same way as did those of Indira Gandhi or Siddhartha Sankar Roy.

But do we see any real step towards that end? No, rather the 'left front' spokesmen are saying that they will soon initiate propaganda ca m paign against price rise! Explaining the intention of this campaign, Sri Promode Dasgupta has said that "the mass campaign on the economic and democratic issues are intended to bring popular pressure on the Central Government"

He also says that "our party holds the definite view that wholesale trade in about eight to ten essential commodities must be taken over by the Government". That is to say people's attention will be diverted to Central Government, urging it to take over wholesale trade in eight to ten essential commodities but meanwhile let the profiteers and the hoarders—the sharks loot the prople. The State Government and the fronts' responsibility ceases only by placing this demand to the Central Government. What about the Chief Minister's bold declaration to the Blitz editor that even if the Central Government sits pretty, his government can not sit quiet but would "mete out, drastic punishments" to economic offenders by 'summary trial' in 'special courts' and that they will be 'rounded up'? It seems therefore that on the one hand such heroic words are being uttered for all India publicity by the Chief Minister but in reality they are trying to divert peoples' attention to the centre, shirking their minimum reponsibility to protect the people from the rapa-

nals? Does this antique differ in any way from that of the previous Congress regime? Was it not a fact that S. S. Roy, the previous Chief Minister made the same 'bold' declaration and even encouraged his youth cadres to gherao Barabazar or Birla's house, took the so-called dehoarding drive as diversion tactics but did not touch the real problem and thus allowed the profiteers to mint fabulous speculative gains at the cost of people's life? If that was crash political dishonesty as all the leftist leaders now in government told that day, what they themselves are doing now? Do they dare touch the real problem to prove their minimum political honesty?

The Finance Minister of the West Bengal Government has recently announced that it will give subsidy to certain items of consumption to provide relief to the people. From the face of it, it may appear that people will get relief but in reality it will add to the superprofits of the black marketeers unless they take at the sametime stern measures against the speculators. The government can not give sanction to arbitrary price manipulation. But if it does not take any measure against the blackmarketeers but just give subvention what it will mean? First, there is no guarantee that the subsidised items will be of the same quality. There is every possibility of these being of inferior quality. The dishonest traders will mint lakhs of rupees coming as government subvention by adulterating the articles. Secondly, this will stabilise the present high prices of the commodities giving governments' seal of approval. And thirdly, which is the most siniser part of the move, is that it will give an air of relief on price front and thereby distract people's mind from movement. So, by draining the public money, profiteers' pockets will be lined, they will be

protected and covered up from the wrath of the exploited people at their own cost. Splendid! What can be a better service to the blackmarketeers and hoarders? Even the State Congress ministry could not go to that length.

But where lies the real

problem? Is it in increas-

ing production alone? Nobody is opposed to increase in production, other than the capitalists who are guided by the motive of maximisation of profit. Workers have increased production all these years by their toil. But have they got any benefit from this increase in production? The Congress leaders gave the hoax to the people that production had not increased and that it was due to this that there was high prices. How come that spokesmen of the left front are also talking in the same vein? They are saying that "they do not want to give any stunt" and that the remedy lies in increasing p r o d u c tion. People of our country have a different experience. They have seen that when surplus food stock has posed a problem to the government for storing, prices of food have not come down, instead they have increased. So what relevance is there of prices of food articles to actual level of production in this capitalist economy where prices are determined on the basis of the law of maximum profits? But that is about the law of determining the average market price of commodities based on maximisation of profit which can not be otherwise so long this capitalist productive system remains. But over and above this average market price, speculative price increases are there which are bringing hell to people's life. Can not this speculative price manipulation be arrested by the govern= ment? Yes, it can be done and has actually been done in many bourgeois countries. Those who plead after having placed themselves in the government that nothing can be done in regard to this speculative manipulation of prices are simply

falsifying the truth. Truth is that, the speculators-hoarders blackmarketers whatever term one may use against this tribe they have a chain of their own which is composed of the big landowner businessmen, bureaucracy including police with liquid simply an eyewash, as it will fund, whether of their own inevitably fail to touch the or supplied by the banks and other financial institutions. They take hold of the stock of agricultural products both by avoiding payment of government levy as well as by purchasing the distress sale of small and marginal peasants. They become the wholesellers and the hasking mills are also at their disposal. Now they operate with the direct aid and assistance of the bureaucrats and police. They have also raised an army of roughs who move under the direct protection of the police. So, if anybody wants to attack this vicious problem of speculative manipulation of prices if he is serious then he must move on two fronts and concentrate on equitable distribution products. First, one is to break this evil chain of these gangsters with stern administrative measures. But one can not succeed by mere depending on the police and bureacracy which are themselves partners of this vile business. It is no use patting some officers as good because it is no ques tion of any individual being good or bad. It will be of no avail in the matter breaking this powerful chain. For this, utilising the government machinery, one is to spot the particular links of the chain and take strong measures against them and organise people's movement against these enemies of the society. Stern administrative measures will have to be brought to effect backed by strong public pressure. In order to bring this popular pressure to bear upon, this popular preasure is to be given concrete

shape of people's committees down to the village and mahalla level. If this can be done then and then only a real battle of the people against their enemies be on. will Secondly, our party has again and again brought to the people the fact that mere taking over of wholesale trade will be bottom of the problem. From the peculiar features of our country as also the concrete experience of the past will ${f show}$ the wholesalers have no difficulty to turn retailers overnight to carry on the illicit trade. So, they are to start from the root, they are to takeover the entire trade at the hands of the government down to the retail level. The government can very well employ the vast army of unemployeds both at the rural and urban sectors including the petty shopkeepers and small traders weaning away from the clutches of the evil chain of speculators-bureaucracy = police combine. It can go to a certain extent to free the food grains trade from the speculative price manipulation as also do the useful service of giving employment to thousands of poor people who because of their destitution fall easy prey to the conspiracy of the economic criminals against the society.

This task which is an important democratic measure is definitely within the power of a state government. But in order to accomplish this urgent democratic task, one is to be bold in the real sense. not merely in words. One will have to give up the policy of appearement to the police, bureaucracy, the business gentry, village jotedars and even middle peasants having surplus in grains. One will have to be firm even against the army of loompens who have fallen victims to immoral way of life.

But instead of taking this real task, an urgent democratic task, the left front ministry in West (Contd. to Page 8)

The management of Assam Carbon Produc's Ltd., a concern of Goenka & Himmatsinka monopoly houses, taking advantage of 'Emergency' was so long following anti-labour practices and resorted to widespread retrenchment and was depriving the employees of conducting their lawfull trade union movements. The Employees' Union of the Assam Carbon Products Ltd. affiliated to UTUC (Lenin Sarani) tried for negotiated settlement at the bipartite and tripartite levels, of their legi-

timate demands for Bonus for 1975-76, re-instatement of victimised employees, revision of pay scales etc. which having failed was compelled to go on strike with effect from 12.8.77,

The Labour Department of Assam Government in the meantime, instead of locking after the interest of the employeer, came to the rescue of the monopoly house by making references to one or two picked up secondary demands of the employees. The Labour Department not only left behind the

Police must not Interfere in the Legitimate Democratic Movements

met the Prime Minister and placed on behalf of the Party's Central Committee a memorandum demanding. among other things, that as against the practice of the last Congress Government the Janata Government should not allow its police to interfere in legitimate and democratic mass movement and take recourse to forcible suppression of such movements. In reply the Prime Minister said, as a Gandhite he himself might be a believer in non-violence but his government might not be-Thanks to the Prime Minister for his franckness, he has proved himself ruthful in Rajhara, Jitpur, Bokaro, Barahiya and so on and so forth!

During the 19 months Emergency when people's fundamental freedom and democatic rights were most ruthlessly suppressed, workers' right to strike, to organise movements or any form of militant struggle, even the right to dissent were denied, the CPI(M),in tune with other bourgeois and social democratic parties, blamed those oppressive measures just as an act of an individual dictator. And after the election CPI(M) party claimed that a qualitative change had taken place. But our party has all along given the warning that those oppressive policies and the proclamation of Emergency were not a question of an individual clinging to power but were taken to protect the capitalist system in the throes of a deep crisis. Due to the all-embracing crisis in the political, economic and social system people's rising discontent had burst forth in waves after waves of protest on all corners of our country. The bourgeoisie, panicky of this popular upsurge of the masses which endangered the capitalist system itself, drastically curtailed democratic rights and civil liberties of the people

to save the crisis-ridden, chaotic capitalist system. But the 'bitter pill' of Emergency could not cure the ills and the economic crisis became even more intense and the sufferings of the people more acute than ever. As a result people's wrath became directed, with increasing vehemence, against the totally discredited dictatorship of the ruling party. The bourgeoisie who realised the danger in the emer. gence of militant mass movement under the leadership of left and democratic parties headed by a working class party, initiated the process of Two party democracy in our country. Thus, the bourgeoisie placed another alternative party of their own class who would stand in defence of the capitalist system before the people. The aim and object of this is to divert people's attention and their grie? vances and keep their legitimate mass movements within the confines of parliamentary reformism and legalism, while clamouring at the same time for restoration of democratic rights and civil liberties. Actually when a proletarian party raises the slogan for restoration, preservation and extension of civil liberties and democratic rights it does so with the sole object of strengthening and extending scope for legitimate democratic mass movement, to intensify the revolutionary class struggle, to educate the masses and to prepare them politically and organisationally for overthrow of capitalist system. But when the bourgeoisie or the social democratic parties raise the slogan for restoration and extens ion of democratic rights they do so merely to exploit the anti-ruling party feelings of the people for their own parliamentary ends. And once they are seated in governmental power these parties do not even restore the demo∍

cratic rights and civil

in order to buy time and liberties, or restore only just as little as is needed to run a Two-party system smoothly, not to talk of extending these rights. This is the nature and the extent of their concern for democratic rights and civil liberties. Long before, our great departed leader and teacher Comrade Shibdas Ghosh taught us that in the era of imperialism and moribund capitalism, the bourgeoisie are more attached to militarism and bureaucracy and less attached to democracy and liberty however much they may clamour about liberalism and democracy. The truth of this analysis has been demonstrated by the Janata Government itself. their six month's rule they have let loose an orgey of violence and ruthless suppression of people's democratic rights. So, even though the party in power may talk of restoration of democratic rights reality shows a different picture altogether, and legitimate trade union movement is suppressed in the most ruthless manner. From this the working class must take lesson and know that at the time of intense crisis of capitalism the bourgeoisie, whichever be the party in power, takes recourse to savage oppression in order to defend capitalism.

> We demand that this oppression must be stopped and that the police must not interfere in the legitimate democratic movements. Unless this principle is accepted and faithfully implemented all talk of restoration of democratic rights is nothing but an empty slogan, a bunkum: it is meaningless for the common people.
